

MINUTES OF THE WASLI 2023 GENERAL ASSEMBLY JEJU, SOUTH KOREA ON 6th JULY 2023

The General Assembly started at 1pm, Jeju time.

The General Assembly was held as a hybrid meeting, with National Members attending in-person and online. Voting online was done through a secured mentimeter website link.

1. Welcome

The WASLI President welcomed all delegates.

The WASLI President introduced the Executive Board members present: Susan Emerson (VP; in person), Dr Isabelle Heyerick (Secretary; in person), Arūnas Bražinskas (DIA; in person), Nigel Howard (Treasurer; in person); Michèlle Berger (Swiss Board Member, online).

A warm welcome was extended to the Regional Representatives.

The President thanked all interpreters working at the GA, in person and online. He also thanked ASLI UK (Association of Sign Language Interpreters in the UK) for sponsoring one of the IS<>ENG interpreters working at the GA and conference.

The following opening announcements were made:

- 1. National Members are voting members. Each National Association can have two delegates at the GA, who together have one vote. Observers are welcomed to the GA, but do not participate in the meeting.
- 2. National Members were asked to register for the GA. Only those National members registered will be able to vote.
- 3. All National Members received the GA information package prior to the meeting which contained all information. This package contained the agenda of the GA. The Secretary did not receive any comments or requests regarding the agenda.
- 4. The Secretary did not receive any proxy votes.

WASLI has 52 National Members representing 48 different countries. 41 National Members have registered to attend the GA representing 39 countries. Please refer to Appendix B for the Official List of National Members attending the General Meeting.

The President made sure 25% of the registered National Members were in attendance before starting the GA.

The Secretary received apologies from SCOSLI (Scottish Collaborative of Sign Language Interpreters).

The Vice President and DIA asked the Regional Representatives present in the room to come to the stage, and those attending online were featured on screen through Zoom. The Vice President and DIA expressed the Board's gratitude for their 4 years of service.

No secret vote was requested. Voting was done by show of hands by in person attending National Members and through online voting by online attending National Members.

9. Approval admittance new National Members

The President explained that following the WASLI Articles (new since 2019), new National Members need to be approved by the General Assembly. The Executive Board does a first administrative check of founding documents regarding eligibility.

The General Assembly needs to formally accept the membership.

a. Guatemala

Executive Board position: accept.

There were no questions. National Members were asked to formally accept Guatemala as a new National Member.

No secret vote was requested.

Voting was done by show of hands by in person attending National Members and through online voting by online attending National Members.

In person vote: approve 18; against 0; abstain 0 Online vote: approve 15; against 0; abstain 0

b. Malaysia

Executive Board position: accept.

Lucy Lim, delegate of the Interpreters and Translators Association for Selangor and KL Deaf Community (JUPEBIM) asked the floor. Miss Lim remarked that JUPEBIM would not support the membership as the Malaysian organisation applying for membership represents deaf people, was a WASLI member 25 years ago, but did not engage with interpreting advocacy work since then.

Wan Zuraidah Abu, delegate of the Malaysian Association of Sign Language Interpreter delegate attending online clarified that MyAsli is not the organisation for deaf people, but a newly established NASLI, was never a member of WASLI before, and is not the same organisation Miss Lim is referring to.

The discussion was closed.

National Members were asked to formally accept Malysia as a new National Member. No secret vote was requested. Voting was done by show of hands by in person attending National Members and through online voting by online attending National Members.

In person vote: approve 17; against 2; abstain 2 Online vote: approve 11; against 1; abstain 5

c. Morocco

Executive Board position: accept.

There were no questions. National Members were asked to formally accept Guatemala as a new National Member.

No secret vote was requested. Voting was done by show of hands by in person attending National Members and through online voting by online attending National Members.

In person vote: approve 21; against 0; abstain 0 Online vote: approve 8; against 1; abstain 6

There were no questions. National Members were asked to formally accept Guatemala as a new National Member.

Executive Board position: accept.

There were no questions. National Members were asked to formally accept Guatemala as a new National Member.

No secret vote was requested. Voting was done by show of hands by in person attending National Members and through online voting by online attending National Members.

10. Determination of membership fees

Attendees were reminded of the four WASLI Membership categories. The fees are determined on the country's GDP, resulting in a Category A, B, C, D, and E. National Members were reminded of the fact that they can renew membership for a period of four years. This ensures voting rights at the General Assembly.

KASLI (Korean Association of Sign Language Interpreters) raised the question whether it was possible to pay in person (cash) for one year now at the conference, and pay for the 3 years via PayPal. The Treasurer responded that he will sort this out with KASLI while here at the conference.

11. Ratification of the annual budget

The Treasurer presented the annual budget.

ASLIN (Association of Sign Language Interpreters in Nigeria) asked the WASLI Board to for future meetings send the annual budget out prior to the General Assembly.

The Secretary responded that the annual budget was sent to all National Members on Tuesday July 4th. She acknowledged that this was late, but the Board wanted to include the financial overview of the WASLI 2023 conference. These accounts were presented to the Board on July 4th after which the Annual Budget was updated and sent to all National Members. For future meetings the Board will aim to have this information with the National Members earlier.

There were no other questions. The President asked National Members to formally accept the report.

No secret vote was requested. Voting was done by show of hands by in person attending National Members and through online voting by online attending National Members.

12. Presentation of Reports and Accounts

The President announced that outgoing WASLI Secretary Dr. Isabelle Heyerick will chair the WASLI ISO Expert Group, which was previously chaired by Samuel Chew. The President thanked Samuel and the members of the working group for their work and contribution.

Dr. Isabelle Heyerick gave an account in International Sign of the ISO Expert Group report (*Please refer to the Report in Appendix A*). There were no questions.

b. ISAAB

Honorary President Dr. Debra Russell gave an account in International Sign of the ISAAB report (*Please refer to the Report in Appendix A*). There were no questions.

c. WASLI Conference accounts

The President called the Conference Convenor, Dr. Anthony Chung to the floor. The President expressed his gratitude to Anthony and Lucy Lim for organising this successful conference.

Dr. Anthony Chung gave an account in International Sign of the WASLI Conference accounts (*Please refer to the overview in Appendix D*). There were no questions.

13. Appointment Regional Representatives

For each of the nine regions two Regional Representatives are elected: one deaf and one hearing.

The National Members of each region were asked to nominate representatives. Consequently, the National Members of each region could vote for the RRs for their own region. At the GA the results were announced of the regional voting which was held online and closed on July 5th at noon Jeju time.

- g. Europe Region: Dr. Christian Rathmann (deaf) was nominated. We received a nomination from the floor for the hearing representative: Anja Saft (hearing) supported by the National Members of the Europe Region. Anja Saft was elected as hearing RR.
- h. Latin American & Caribbean Region: Laura Astrada (hearing) & Christian Ramírez Valerio (deaf)
- i. North American & Mexico: Ronise Barrera (deaf) & Eduardo Daniel Maya Ortega (hearing)

Question (online): ANILSEC Is it correct that the new hearing RR for the Asian region is also candidate for the VP position? Is this allowed? Can one person hold the same position?

Question from the floor by ASLI India: same question: what happens if the same person is elected as VP?

The Secretary answered: Dr. Lydia Koh was nominated for both positions. It is possible to be nominated for more than one position. However, it is not possible to combine two WASLI Board positions. We will need to carry out the vote for VP (as there is another candidate). Dr. Lydia Koh has informed the Secretary that if she is elected as VP, she will not take on the position as Asian RR. In that case, we will need to discuss this with the Region and see if the other nominated candidate (Noriko) is happy to take on the mandate. All depends on the results of the vote for the VP position.

The President asked the appointed RRs to either come to the stage or turn their camera on and congratulated them on their appointment. The WASLI Board looks forward working with them the upcoming four years.

14. Appointment Executive Board

This part was led by outgoing Vice President Susan Emerson and outgoing Secretary Dr. Isabelle Heyerick.

The candidates had been announced in the GA Information Package which contained their picture, bio, and motivation.

At the GA, the candidate(s) were presented and were asked to make themselves known. National Members had the opportunity to ask questions before moving on to the vote.

For the positions of Vice President, Secretary, and Treasurer a secret ballot was requested by more than five National Members.

National Members in the room voted by paper ballot. National Members voted online. The votes in the room were collected by the tellers, and at the end of the procedures they were counted. The Secretary checked the count of the paper ballots, and the results of the online voting before announcing the results. No counts were made public.
